### Tax points for solar inverters

What are the tax benefits of solar power? The tax benefits can include income tax credits, breaks on local real estate taxes, and enhanced depreciation of solar assets. However, the advantages extend beyond income tax incentives, as many states, power companies, and municipalities offer additional incentives, such as partial reimbursements or purchases of excess power generation.

How much tax credit can a solar PV system receive? In 2006, and 10% for systems commencing construction in 2005 or thereafter. Any PV system placed in service after 2005, regardless of when it commenced construction, can receive a maximum tax credit of 10%.<sup>2</sup> Typically, a solar PV system that is eligible for tax credits must use new and limited previously used components.<sup>3</sup> Systems must use new and limited previously used components.

Are solar power systems eligible for tax credits? Tax credits: Regardless of their status as either a trade or business or a nonbusiness activity, solar power generation systems may be eligible for either an investment tax credit under Secs. 48 and 46 or a production tax credit under Sec. 45. Are solar power systems tax deductible? Personal-use solar power systems are eligible for a federal income tax credit under Sec. 25D. This credit is available only for the taxpayer's personal residence and equals up to 30% of the costs of qualified property installed. The cost of the system, net of the credit, forms the basis in personal property. Is a solar rebate taxable income? Amount of the ITC claimed; however, the rebate is not considered taxable income. For example, if the tax basis is \$1,000,000 for a PV system installed at an apartment complex and the utility gave a one-time rebate of \$100,000, and the project commenced construction before December 31, 2005, and was placed in service on or before December 31, 2005, the rebate is tax-exempt and subsidizes the project.

Do solar projects qualify for a bonus tax credit? On May 16, 2006, the IRS issued Notice 2006-41, which significantly simplifies the calculations to determine if solar, onshore wind and battery projects qualify for a 2% or 10% bonus tax credit for using enough domestic content under the Internal Revenue Code sections 45, 45Y, 48 and 48E.
